- Individual Student Reports (ISRs) must be provided to families **within one month** of the LEAs receiving the paper copies.
- **New:** For students who took the test at an outplacement school, ISRs will be shipped to the outplacement schools. These schools will be responsible to provide ISRs to families and send a copy to the sending LEA.
- RIDE will be reaching out to LEAs regarding students who may have taken the incorrect test (Alternate ACCESS vs ACCESS). LEAs will be asked to submit an irregularity for these students.

ACCESS & Alternate ACCESS

Reporting Resources:

- **Communicate with families:** Use customizable [ACCESS for ELLs Parent Letters](#), available in the same 49 languages as the ACCESS for ELLs Individual Student Report (ISR), to share general information about ACCESS for ELLs. Include our [ACCESS for ELLs: Understanding your Child's Scores](#) or [WIDA Alternate ACCESS: Understanding Your Child's Scores](#) flyers to help parents understand the ISR.
- **Communicate with your colleagues:** Use the [ACCESS for ELLs Interpretive Guide for Score Reports](#) and [WIDA Alternate ACCESS Interpretive Guide for Score Reports](#) to explain ACCESS scores to your fellow educators. In addition to providing an overview of the various types of score reports, these resources explain how scores are calculated, and how you can use proficiency level and scale scores to support your students' language growth.

NGSA: Testing Starts April 28.

- Preliminary scores will be available in the Cambium Reporting Service (CRS) on June 6, 2025.

Tasks to Complete Before Testing Window Opens:

- **Accounts in TIDE:** District Test Coordinators are responsible for creating School Test Coordinator and Test Administrator accounts in TIDE.
- **Student IEP and ELL flags:** Check your student data! We populate the IEP flag using the information from the special education census. We populate the LEP flag using the data from the LEP Census.
- **Set accommodations in TIDE:** *See above bullet.* Only students with IEP and/or MLL* flags can receive accommodations in TIDE. This includes *monitored MLL students*.
 - *Accommodations and Accessibility Features Manual* available at www.ride.ri.gov/accommodations.
- **Train Test Administrators:** All test administrators must be trained. See earlier slide for training requirements.
- **Use the Test Coordinator Checklist:** located in the front of the Test Coordinator Manual!
 - All manuals are located on the NGSA Portal (<https://ri.portal.cambiumast.com/>):
 1. Click on **ADMINISTRATOR'S CARD**
 2. Scroll to the bottom of the Administrator's page until you get to *Associated Resources*.
 3. Click on **TEST COORDINATOR MANUAL (TCM)**

NGSA: Item Review Committees

HOW to Apply: Educators should complete the [application for NGSA Item Review Committee](#) (Due May 30, 2025):

DLM: Test window is now through May 30

Tasks to Complete:

- **Roster all students:** There are STILL students who are not on rosters. Exit all students who are not taking DLM from Kite Educator Portal.
- **Make sure teachers complete the test administrator training in Kite Educator Portal.**

Reminders About Test Irregularities:

- Not using the TIP sheet to administer testlets is a test irregularity.
- Administering a testlet in under 60 seconds (Short Testing Time) is a test irregularity
- These may result in invalidation of test scores.

DLM: Assessment Flags in Special Education Census

- 68 students are registered for DLM in Kite Educator Portal and do not have the alternate assessment flag in the Special Education Census.
- Special Education Directors and data managers received an email from Samantha Clarke (OSCAS) if you had a student without the alternate assessment flag.
- Double-check to make sure students in the Special Education Census have the correct assessment flag:
 - *1= general assessment with no accommodations*
 - *2= general assessment with accommodations*
 - *3= alternate assessment*
- Questions about updating the Special Education Census data? Contact your District Special Education Director and your Data Manager.

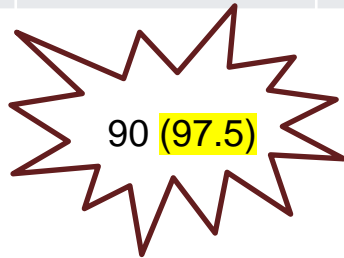
If a student is administered **the wrong test according to the Special Education Census data RIDE receives from your LEA**, this is a test irregularity, and you will be required to submit a test irregularity report. Any tests a student takes that does not align with their assessment designation in their IEP as documented in the Special Education Census will be invalidated.

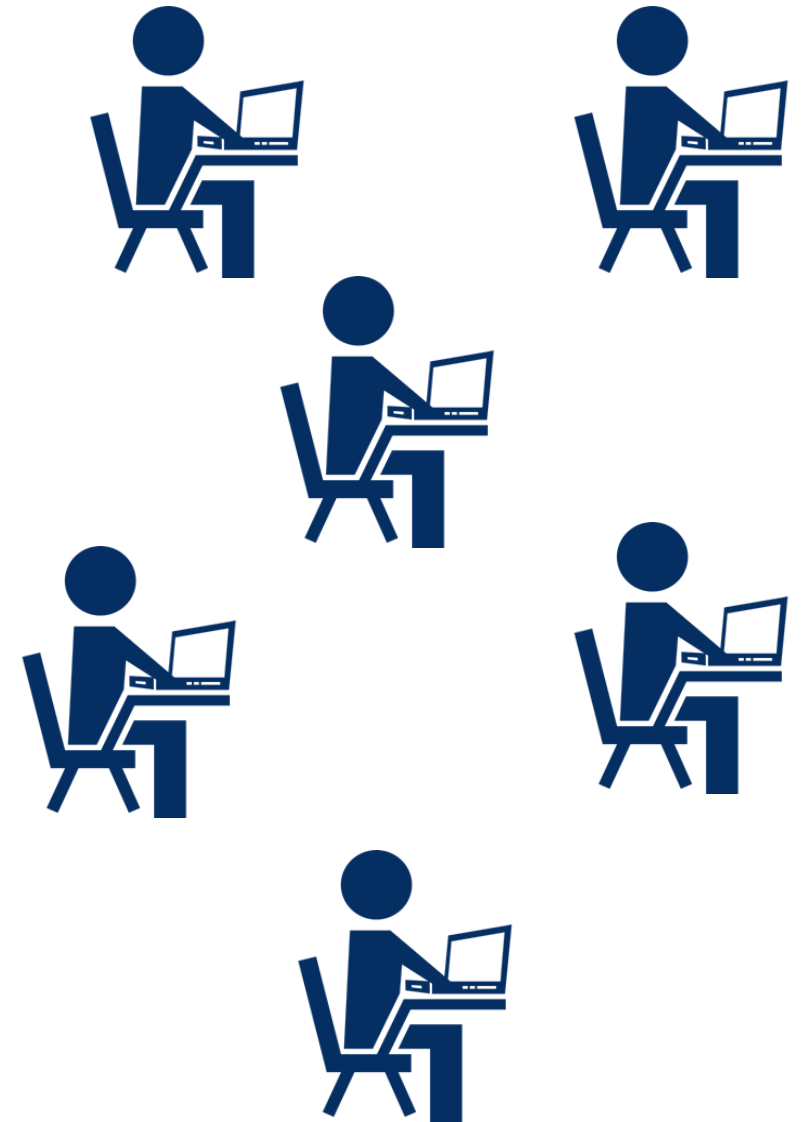

RICAS ELA closes Friday, April 25th

- Schools must **schedule** the ELA UPS pickup in the RICAS Service Center by **April 24th**.
- Last day for UPS PICKUP is **April 28th**.



RICAS Math opens Monday, April 28th and closes Friday, May 23rd

- Schools must **schedule** the Math UPS pickup in the RICAS Service Center by **May 23rd**
- Last day for UPS PICKUP is **May 27th**
(reminder: Memorial Day is May 26th so plan accordingly)

Frequently Asked Questions About RICAS

Unlocking/Completing Test Reminders

A student test MAY be unlocked	A student test may NOT be unlocked
<ul style="list-style-type: none">• A device experiences an abrupt closure due to power failure or unexpected shut down• A student was in the middle of the CR when they exited and got locked out of the test.	<ul style="list-style-type: none">• If a student leaves testing early due to illness or early dismissal (the student may complete testing upon return to school).• Student returns from lunch after 30 minutes has passed• If a malfunction occurs during the test submission process, and the test coordinator logs in to submit the test later in the day.
Students must complete testing before the end of the day in which it was started; students must finish before the school day ends and submit whatever has been completed before leaving for the day.	<p>A test can be completed after the day in which it was started in the following circumstances:</p> <ul style="list-style-type: none">• The student went home ill (test must remain locked)• The student experiences manifestation of a behavioral disability during testing (test must remain locked)• The student was dismissed early (test must remain locked)• The student/class experienced an internet outage, fire alarm or emergency during testing that did not allow for ample time to complete the assessment upon resolution on that day (test must remain locked)• A student has an approved "testing over multiple days" accommodation that RIDE is aware of

During Testing FAQs – Testing Interruptions

What do I do if there is a school emergency, and students must leave the building?

- Safety comes first. If it can be done safely, have students log out of test platform or close test booklets (PBT) before leaving the testing area.

If a student becomes sick or otherwise is required to stop testing before they have submitted, what should I do?

- The student should log out (CBT) or close their test/answer booklet with a piece of blank scrap paper marking their place (PBT, ideally indicating the item number) and the test administrator collect the student's testing materials.
- The student (and family) should be informed that they should not discuss the test, that the student will resume testing (test must remain locked) after their return to school and will only be allowed to work on test items that the student has not viewed or answered.
- School should complete a test irregularity report **at the time of the irregularity** and await instructions from RIDE.



During Testing FAQs-Testing Interruptions

What do I do if one student's device has issues, but the student is logged in and the problem cannot be resolved within 15 minutes?

- If you have contacted the RICAS Service Center and the problem still cannot be resolved within 15 minutes, you should schedule the student to complete the session at a later time if time no longer permits completion.
- If a student needs to swap a device, you must call the RICAS Service Center first to confirm that all data has been uploaded to eMetric before moving to the new device.



What do I do if many students are affected by a power/internet outage?

- Circumstances over which you have no control (e.g., power failures) may interrupt testing. *The TAMs include specific instructions for test administrators to follow if an interruption occurs.*
- When normal conditions are restored, have students resume testing. No interruption should reduce the total amount of time that students are given to complete the interrupted test session.
- School should complete a test irregularity report **at the time of the irregularity** and await instructions from RIDE



During Testing FAQs: RICAS Testing Interruptions

How do I know if there is a system-wide outage during testing (e.g., RICAS testing servers go down)? How is that handled?

- First check to see if it is a vendor issue ricas-status.emetric.net
- If the school cannot restore the network, secure tickets, make note of who was on each device and complete a test irregularity report **at the time of the irregularity** and await instructions from RIDE.



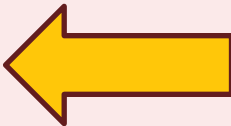

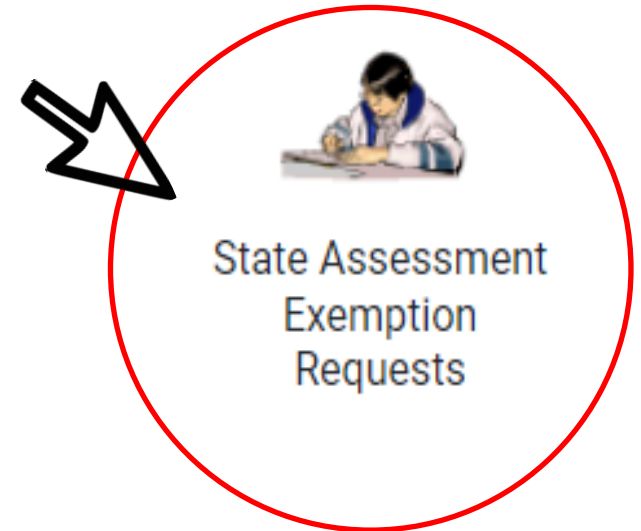


Medical Exemption Criteria

- To be considered for a medical exemption, the student must have a documented and significant medical emergency that extends through the state testing window.
 - The student must be unable to test due to their medical emergency during the primary and secondary window of testing.
- Two criteria need to be met for a student to be eligible to apply for a medical exemption:
 - The student's medical situation is so severe that they cannot receive instruction in any setting.
 - Examples: home, school, hospital, or outplacement facility.
 - The student cannot participate in the assessment, even with accommodations.
- If the student's situation does not meet these conditions, then the student is considered able to participate in the state assessment(s).

- Complete hardcopies of Forms 2 and 3.
 - Do not send these to RIDE, keep them on file at the district.
- To submit, the District Superintendent will log into the RI Portal (<https://portal.ride.ri.gov/>).
- Click the State Assessment Exemption Request Icon.
- Complete Form 1 online via the app.
- Click SUBMIT.

Best Practices for Selecting Your Testing Windows

1. Determine how many staff you will need *before* selecting your testing window.
2. Use as much of the state testing window as possible. Even if your school testing window is over, if you're within the state assessment window, you can continue testing.
3. Plan to test 100% of students in each content area.
4. Start as early in the state primary testing window as possible.
5. Adhere to the state testing window for make-up testing.
