# SAT and PSAT Updates and Helpful Resources

---

## Text-to-Speech for Math Sections (Embedded)

- SSD Coordinators will now be able to request TTS for the math section only.

## Screen Reader no longer paired with extended time

- Students who require extended time with screen reader will need to have that accommodation requested separately.

## EL Text-to-Speech for Math Sections (Embedded)

- MLL students are now eligible for TTS for the math section only.
- These scores will be college-reportable.
- SSD coordinators will choose the option from the EL supports section of SSD Online.

# 2026 RICAS Updates

---

## RICAS Portal

- ✓ TCs will be able to **export an accommodations report** for all students
- ✓ New users will receive a **single email** with both their username and password, instead of two.
- ✓ Session Access Code will now be “Access Code”.
- ✓ TCs can **bulk print student logins** for ALL tests in one download
- ✓ “**Progress View**” on the View Details page allows TAs to see how many items each student has visited and answered, overall status, last activity recorded.

## 2027 ELA Test Design

- ✓ MA is developing new test designs for the grades 3–8 ELA MCAS tests, which are expected to be operational in spring 2027.
- ✓ MCAS and RICAS will be **field testing** new question types in spring 2026. **(The operational test will remain the same for 2026)**
- ✓ Some of the new anticipated features for the 2027 tests include:
  - one-point selected-response items (including multiple-choice, multiple-select, and technology-enhanced items)
  - shorter reading passages to answer selected-response questions
  - extended response questions that will expect a response of about one to two paragraphs
  - one-point standalone selected-response questions that will assess grade-level language standards and will not be associated with a passage

# 2026 RICAS Updates

---

## RICAS Student KIOSK

- ✓ A message will pop up on the screen warning students that the **test will timeout** due to inactivity with a 1-minute timer.
- ✓ **Answer Eliminator will no longer be available** for students but may continue to access the answer masking feature which provides the same level of support.
- ✓ The **names of the colors for color contrast** have been updated to be more descriptive rather than being named (i.e., orange on brown).
- ✓ The **ruler** has been updated to a **blue color scheme**.
- ✓ The TI calculator has been updated to the latest version and all calculators (TI, eMetric and Desmos) will show degrees by default.
- ✓ Student's **name will appear in the top right corner** of the directions page.
- ✓ All RICAS ELA tests will **transition from a character counter to a word counter for constructed response and essay questions**. The word limits are similar to the previous character counter limits.





# Text-To-Speech/Human Read Aloud for RICAS Math and NGSA

---

**NEW for 2025-26:** TTS and Human Read Aloud are now a **special PLP accommodation** for RICAS Math and NGSA Science.

- **This does mean** that students identified as MLL **or** students who have a PLP (Personal Literacy Plan) receiving a tier 2 or tier 3 reading intervention, may benefit from text-to-speech (TTS) for the math tests in English and, for NGSA science, English and Spanish.
- **This does not mean** that all students should receive this test support “just in case”. This is for students who have PLPs.



# NAEP 2026 Assessment Logistics



## School Coordinator

- Record school start and end time
- Select the desired assessment grouping option (for school device schools)
- Schedule the assessment groups and reserve space at your school.
- Review the assigned assessment group for each sampled student and update students' group assignments as needed.
- Provide assessment day details, including
  - procedures for arriving and checking in on assessment day;
  - classroom protocols;
  - who to contact in case of emergency; and
  - how the school would like students to be dismissed after the assessment.







# Best Practices for Selecting Your Testing Windows

---

1. Determine how many staff you will need *before* selecting your testing window.
2. Use as much of the state testing window as possible. Even if your school testing window is over, if you're within the state assessment window, you can continue testing.
3. Plan to test 100% of students in each content area.
4. Start as early in the state primary testing window as possible.
5. Adhere to the state testing window for make-up testing.
