

Evidence-Based Review Tool / Organizer

To determine if an activity, intervention, or strategy meets the ESEA/ESSA evidence-based criteria the following questions should be reviewed.

Step 1: Stakeholders identify areas of need through a needs assessment process.

Note that the LEA and school report card organizers can be used to assist with this needs assessment process.

Step 2: Use an Evidence-Based catalog to find studies aligned to the LEA/school need.

Studies should be collected using evidence-based catalogs. The questions below will then help to determine if an individual study will meet the requirements of evidence-based.

Step 3: Determine if the study meets the Evidence-Based criteria required for the Federal Program. **LEA Name:** 1. The LEA needs assessment process identified an area(s) of need.
