Timeline of ESSA Accountability during COVID-19

2020

- All states waived accountability and state assessments due to COVID-19
- RIDE developed an LEA accountability system which generally matches school accountability and includes new systems for district-level support

2021

- US ED encouraged states to request waivers for accountability; RIDE requested and received approval for an ESSA accountability waiver
- State assessments were still required

2022

- Return to Star Ratings; maintain longitudinal meaning
- Some changes may be necessary due to data availability or other effects of COVID-19

 - Commissioner's Seal & Postsecondary Success ("Diploma Plus Credentials")
- Accountability State Assessment Data Validation July-August
- Accountability ACCESS Data Validation TBD, no later than July-August

Commissioner's Seal:

- Are any assessments missing?
 - Includes: SAT, PSAT, AP, ACT

Postsecondary Success ("Diploma Plus Credentials"):


- Are any credentials missing?
 - Includes: AP, CTE, College Credit



What is the Commissioner's Seal measure?


The Commissioner's Seal measure reports the percentage of high school graduates who **demonstrate high school proficiency in both math and ELA**.

Students have multiple opportunities to demonstrate proficiency on any approved assessment.





Where do the Commissioner's Seal data come from?




What is the Postsecondary Success measure?

The Postsecondary Success measure reports the proportion of high school graduates who earn a credential beyond a high school diploma.


Includes a small bonus for students who earn 2, or 3+ credentials, to encourage schools to keep going after the first credential.

All credentials are treated equally.
